- Educational Testing & Evaluation Agency (ETEA) invites sealed bids for contracting services of "SOLARIZATION OF ETEA Peshawar" having PV Capacity of 70kWp under Single Stage Two Envelope Bidding procedure of KPPRA Rules 2014.
- 2. The Procuring Entity invites sealed bids from eligible firms licensed by the Pakistan Engineering Council in the appropriate category for the Works. A foreign bidder is entitled to bid only in a joint venture with a Pakistani Contractor in accordance with the provisions of PEC bye-laws. Sealed Bids for complete scope of work are invited from prospective Bidders to bid for the mentioned project.
